

The regular monthly meeting of the Liberty Township Board of Supervisors was called to order on April 7, 2011 at 7 p.m. Present were Bill Goodrich, Jim Lindsey, Ted Plevinsky, Lori Raub, G. Southworth Jr., Violet Henry, Clifford Reed, Don Rifenburg, Len Kalechitz, Lenny Kalechitz, and Linda Rockwell.

Public Comments G. Southworth asked about driveway permits. A number of trucks are parking along side Liberty Park Road. He stated they were pickup trucks. The supervisors commented that Liberty Park is a state road. Bill and Ted advised him to call the State Police to see if anything could be done.

Minutes Bill made a motion to accept the March meeting minutes as presented. Jim seconded and Ted voted yes.

Road Report Bill reported the following March activities: there were some break downs on roads due to storms; the following roads were repaired: Mill Road, Lower Rhiney, Mt. Valley, Stone Crop, Buck Road, and Mahoney; two trucks were stripped for road work but had to be set back up for snow; plowing and cindering was done, and Andy attended a two-day Conservation Seminar.

Tom McDermott installed a driveway without a permit. A letter will be sent to him.

Liquid Fuels funds of \$83,172.94 and Turnback funds of \$31,800 were direct deposited on April 1.

Snake Creek Volunteer Fire Co. was billed for \$124.79 (first quarter fuel use), and the payment was received tonight before the meeting started.

Old Business The township has received the refund for the cancellation of Jim's attendance at the PSATS Annual Convention-April 17-20.

The supervisors briefly discussed the Time Warner Cable Franchise renewal. It will be advertised in the Transcript, Independent, and Mulligan's the weeks of April 18 and 25.

New Business Linda will complete the DGK Insurance Renewal application, which is due May 1.

No problems were reported with the SCVFC Compliance Audit Report.

Linda will complete the 2011 Act 205 Questionnaire and Reporting form.

The township does not have a local service tax; therefore, the Centax form does not have to be completed.

The supervisors decided not to contribute to the Endless Mts. Visitors Bureau.

Bill made a motion to donate \$50 to the SCVFC if they are having an Easter egg hunt this year. Ted seconded and Jim seconded.

The supervisors decided to take no action on the information from PSATS for Local Government Week.

Meetings The supervisors coordinated their calendars to attend upcoming meetings.

Correspondence Routine correspondence is read and discussed.

Payroll and Check Signing The supervisors signed the checks presented for payment.
