The regular monthly meeting of the Liberty Township Board of Supervisors was called to order on October 6, 2011 at 7:01 p.m. Present were Bill Goodrich, Jim Lindsey, Ted Plevinsky, Clifford Reed, G. Southworth Jr., Violet Henry, Donald Rifenbury, Lori Raub, Lennie Kalechitz, Len Kalechitz, and Linda Rockwell.

Public Comments None.

Minutes Bill made a motion to accept the September 2011 Meeting Minutes as presented. Jim seconded and Ted voted yes.

Road Report Bill reported the following September activities: Storm damage repair to Shadow Brook, Mt. Valley, Hunsinger, Bailey Rd., Howard Hill, Mucky Run, and Valley View. Cleaned sluice heads on Barbour Hill and Holy Road.

Treasurer's Report The Baldwin Stone bill paid out of state funds will be voided and paid with general funds. Bill made a motion to accept the September 2011 Treasurer's Report as presented, pay Bill List 10-11, pay any bills which are normally paid during the month, and pay the payroll for October. Ted seconded and Jim voted yes.

Linda asked whether the PA Labor Law posters should be paid by November 1 for \$57.25. Ted replied that they are required so go ahead and order them.

Linda reported the following for the State Funds audit for 2009-2010: The \$10,000 paid on the line of credit out of liquid fuels was towards the purchase of a \$45,000 dump truck from Bradco; the auditor would like to see the amount of payroll broken out on the line item on the MS 965; be sure to use Line Item 436 for pipes, and the auditor commented that the minutes were some of the finest he had seen—very complete.

New Business Ted made a motion to pass Resolution 11-04: Transportation Funding Advisory Commission. Bill seconded and Jim voted yes. Copies will be sent to Lisa Baker, Gene Yaw, Tina Pickett, and Sandra Major.

Ted made a motion to appoint Lenny Kalechitz to the Liberty Township Planning Commission. Bill seconded and Jim voted yes.
