Minutes Bill made a motion to accept the November 2012 Meeting Minutes as presented. Ted seconded and Jim voted yes.

<u>Road Report</u> Bill reported the following November activities: WPX did road work on English Flats, Mill Road, and Tripp Lake. Equipment repairs were done to the grader, a new plow was purchased for Truck #22, the township building roof is finished, a spreader is on Ford #44, and pot holes were repaired during the month.

Ted opened the bids for the 1968 Kaiser dump truck: Wade Conrad bid \$250.00 and Ken Kublo bid \$2,556.01. Bill made a motion to accept the bid from Ken Kublo. Ted seconded and Jim voted yes.

Bill noted that the township is just looking for a new grader. He has been talking with four (4) vendors for prices. It would go through Co-Stars at 40 percent (40%) of the list price.

Treasurer's Report Ted reported that the township has received gas impact funds of \$229,120.79. Of this, \$60,000 has been put in a capital reserve CD fund. The remainder, \$169,120.79 has been put in an operating reserve fund money market account. Some possible uses being considered are as follows: insulate the building, install a handicap accessible bathroom, building out back, have the electricity checked throughout the building, a new grader, and possibly a dump truck.

Bill made a motion to accept the November 2012 Treasurer's Report as presented, pay Bill List 12-12, pay any bills which are normally paid during the month, and pay the payroll for December. Ted seconded and Jim voted yes.

New Business Bill made a motion to adopt the 2013 budget as prepared. Ted seconded and Jim voted yes.

Bill made a motion to adopt Resolution 12-05: Peoples Neighborhood Bank, Act 13 capital reserve CD fund. Jim seconded and Ted voted yes.

Ted made a motion to adopt Resolution 12-06: Tax Reduction, which would eliminate the 2 mil tax assessment for the equipment fund. Bill seconded and Jim voted yes.

A letter was read from PA Public Utility Commission explaining how the payment was derived for the Act 13 Impact Fee Distribution.
