Public Comments None.

Minutes Bill made a motion to approve the June 2015 Meeting Minutes as present4ed. Dave seconded and Alton voted yes.

Road Report Bill reported the following July activities: road work (Jones Creek, Shadow Brook, Howard Hill – section, Mountain Valley, Smith Drive, Hunsinger, Stone Crop, Cabin West, Bailey, and Holy Road), sluice pipes (Jones Creek—4, clean tails—beavers, Shanty Hill), Dust Control (Shadow Brook, Valley View, Mt.
