

The regular monthly meeting of the Liberty Township Board of Supervisors was called to order by Chairman Doug Sivers on October 7, 2021 at 7 p.m. Supervisors present: Doug Sivers, Dave Bailey, and Alton Wilber. Secretary/Treasurer and alternate Secretary/Treasurer present: Linda Rockwell and Janette Tiffany. Public present: Dennis & Rach Magargal, Lori Raub, Bill Bayne, and Paul DiBiase.

Public Comments Dennis Magargal expressed his concern as a taxpayer about the township finances especially employee insurance and the Wi-Fi in the township building.

Bill Bayne asked that the recycling roll off be moved for the scheduled recycling on October 16.

Minutes Dave made a motion to accept the September 2021 Meeting Minutes as presented. Doug seconded and Alton voted yes.

Scheduled Public Input None.

Road Report Dave reported the following September activities: installed a big pipe on Holy Road, worked Barbour Hill, no winter maintenance road, straightened sections of Lyon & Tripp with the grader and roller, replaced two pipes on Camp Road, cleaned the end of Howard & Cabin Roads with the backhoe, took trucks to Owego for repairs, and removed trees and limbs from roads as needed.

Treasurer's Report Linda reported that the 2018-2020 liquid fuels audit was begun on September 13 and not yet completed. Due to tax collector computer problems, there are no current taxes yet. FEMA buyout funds were received in September and again on October 4. Dave made a motion to accept the September 2021 Treasurer's Report, pay Bill List 10-2021, pay any bills which are normally paid during the month, and pay the payroll for October. Doug seconded and Alton voted yes.

Old Business Doug reported that one closeout (Vince & Lisa Heron) has taken place during the FEMA Buyout. Currently working with Mr. Nase. After he moves, then a demolition bid will be accepted for the two properties.

A discussion ensued regarding the Grange Hall and code enforcement issues. No decisions were made at this time.

Linda contacted the Assessment Office regarding the reestablishment of the 2-mil equipment fund. A form will be sent in December to complete for the 2022 millage.
