An Ordinance regulating junk dealers, the establishment and maintenance of junk yards, including but not limited to automobile junk or grave yards, the storage and disposal of scrap, refuse, and junked articles, providing for the issuance of licenses for junk dealers and for the maintenance and operation of junk yards under prescribed conditions, prescribing remedies for the abatement of nuisances and unlicensed junk yards and scrap yards, prescribing penalties for violators, and providing for the revocation of licenses in the event of non-compilance. the event of non-compilance.

Be it enacted and ordained by

the Board of Supervisors, Liberty Township, Susquehanna County, Pennsylvania, and it is hereby en-acted and ordained by authority of

acted and ordained by authority of the same and pursuant to the authority granted by the Act of Legislature approved May 1, 1933, P. L. 103, as amended, as follows: Section 13 Short Title — This ordinance shall be known and may be cited as "Liberty Township and Junkyard and Refuse Ordinance." Section 2. Definitions — Unless otherwise expressiy stated, the following words and phrases shall be

towing words and phrases shall be construed throughout this ordi-nance to have the meanings herein

indicated; A. Person - Shall include any partnership, association, firm and

corporation

or oration.

B. Township — Shall mean Liberty Township, Susquehanna County, Pennsylvania.

C. Board — Shall mean the Board of Supervisors of Liberty Township.

D. Junk yard — Shall mean any place where any junk as hereinafter defined, is stored, disposed of or accumulated. place

accumulated. er accumulated.

E: Junk — Shall mean any discarded material or article and shall include, but not be limited to, scrap metal, scrapped, abandoned or junked motor vehicles, machinery, equipment, paper, glass, containers and structures; it shall not include however, refuse or

containers and structures; it shall not include, however, refuse or garbage kept in a proper container for the purpose of prompt disposal.—

F. Junk Dealer.— Shall mean any person, as hereinafter defined, who shall engage in the business of selling, buying, salvaging and dealing in junk and who maintains and operates a junk yard within the Township of Liberty.

G. Automobile Graveyard — For the purpose of this Ordinance shall

G. 'Automobile Graveyard — For the purpose of this Ordinance shall constitute a place within the Township where there are stored or accumulated outdoors three or more automobiles not currently licensed with the Department of Highways, Bureau of Motor Vehicles, and not operated as a junk yard as herein defined.

H. License — Shall mean the permit granted to a person who accumulates, stores or disposes of junk as hereinbefore defined.

Section 3. License — No person shall engage in business as a junk dealer, or maintain a junk yard without first having obtained a license from the Board, for which license a fee in accordance with the schedule hereinafter set forth shall she paid to the Township for

the use of the Township. The license shall be issued for the twelve month period beginning July 1, and ending June 30 of the following year, and each license must be renewed annually od or before the first day of July of each year.

The license provided for in this ordinance shall be issued by the Board after written application shall have been made therefor by the person desiring to be licensed. Such license shall state the name of the person to whom such license of the person to whom such license is issued and the premises on which such business is to be conducted, or such junkyard is to be maintained. Such license shall be posted conspicuously upon the premises licensed thereunder. The written application, for license written application, for license hereinabove mentioned shall be achereinabove mentioned shall be ac-companied by a form, every ques-tion of which must be answered, which form will be supplied by the Board. Applicant shall also submit therewith a plot of the premises used or to be used in connection with such license.

Section 5: Issuance of License Upon receipt of an application by the Board, the Board shall issue a license or shall refuse to issue a license to the person applying license to the person applying thereforeafter an examination of the application and taking into conthe application and taking into con-sideration the suitability of the property proposed to be used for the purposes of the license, the character of the properties located nearby, and the effect of the pro-posed use upon the Township, both economic and aesthetic. In the event the Board shalf issue a license, it may impose upon the license and the person applying therefor such terms and conditions in addition to the regulations herein addition to the regulations herein contained and adopted pursuant to this ordinance as may be deemed necessary to carry out the spirit and intent of this ordinance.

spirit and intent of this ordinance.

Section 6. License Fee — The license fee shall be paid immediately upon the issuance or renewal of a license. The amount of the license fee shall be calculated in accordance with the following schedule as determined by the actual land to be used by the person to whom the license is issued, excluding all set-back areas:

A. Less than 10,000 square feet —\$25.00 per year.

-\$25.00 per year.

B. Over 10,000 square feet and less than 25,000 square feet-\$50.00 per year.

In excess of 25,000 square feet

-\$100.00 per year.
Section 7. License Limitation —
No person licensed under this
ordinance shall, by virtue of one
license, keep more than one place of business within the Township or maintain more than one junkyard, for the purpose of buying, selling and dealing in junk. No person shall engage in business as a junk dealer in any place other than the place designated upon his license, or maintain a junkyard in any place other than the place designated upon his license.

Section 8. Transfer of License -No license issued by the Board shall be transferrable by the licenser to any other person unless such a transfer is authorized by the Board. Any person desiring to transfer his license shall notify the Board in writing, which notification shall be accompanied by an application for a license, as described in Section 4 of this ordinance, by

in Section 4 of this ordinance, by the transferce.

Section 9. Transfer fee — In the event the Board shall approve the transfer of a license the transferce shall immediately pay the Town-ship a transfer fee of Ten (\$10.00) Dollars.

Section 10, Regulations - Every

person licensed under this ordi-nance shall constantly maintain the licensed premises in accordance with any special provisions imposed by the Board and in the manner prescribed by this section and any subsequent regulations adopted by the Board:

by the Board:

(a) Such premises shall at all times be maintained so as not to constitute a puisance or a menace to the health of the community or of residents nearby or a place for the breeding of rocents and vermin.

(b) No garbage or other organic waste shall be stored in such premises.

premises.

(c) A person licensed under this organizate shall not burn more than one motor venicie or its equivalent at any one time. No oil, grease, tires, gasoline or other similar material that might be dangerous or tend to produce obnoxious smoke or odors shall be burned within a junk yard at any time. Burning of venicles must be attended and con-

troiled at all times.

(a) The premises to be licensed shall be set back a minimum distance of twenty-five (25) feet from tance of twenty-five (25) feet from the right of way lines on all streets or roads and a minimum distance of twenty-five (25) feet from all other property lines. The area between the set back line and the right of way line and all streets and roads and all other property lines, shall be at all times, kept clear and vacant.

(e) When the Board shall deem it necessary and desirable, the

it necessary and desirable, the premises to be licensed shall at the set back lines be enclosed by a fence of type and style to be de-termined by the Board or by evergreen screen plantings, or both. The Board may set forth the fence and planting requirement at the time of the issuance of a license or at the time of-renewal or transfer

(f) On and after the effective date of this ordinance, no automo bile graveyard as herein defined shall be kept or maintained on any private premises within 500 from the nearest public highway.

Section 11. Violations - Any per-son who shall violate any of the provisions of this ordinance shall upon conviction thereof, by a summary proceeding, be sentenced to pay a fine of not more than Fifty dollars (\$50.00) and the costs of prosecution, provided that each day's violation of any of the pro-visions of this ordinance shall constitue a separate offense.

Section 12. Abatement of Nuisances edies provided in Section 11, above, any continued violations of this ordinance which shall constitute a nuisance in fact or which shall in the opinion of the Board constitute a nuisance may be abated by pro-ceeding against the violator in a court of equity for relief. Section 13. Severability — If any

section of this ordinance shall be found to be invalid the other sec-tion of the ordinance shall not be

Section 14. Repeal — All ordinances or parts of ordinances in conflict herewith be and the same are hereby repealed.
