March 5, 2026

The meeting was called to order by Lori Raub at 7PM. Lori Raub made a motion to advertise for a CDL driver (equipment operator optional). Steve Roe seconded. Darin DeRose said yes. Motion carried.

Lori Raub made a motion to adopt and enact Resolution 2026-2 regarding the LSA grant application for a roller. Darin DeRose seconded. Steve Roe said yes. Motion carried.

The supervisors have received a request for a meeting with Snake Creek Vol. Fire Co. Darin DeRose made a motion to not set up a private meeting with them, but to have them meet with the township solicitor if they want a meeting.. Steve Roe seconded. Lori Raub said yes. Motion carried.

Lori Raub made a motion to pay the auditors for 2025 and 2026 due to not being paid in 2025. Steve Roe seconded. Darin DeRose said yes. Motion carried.

Lori Raub made a motion to open a bank account with Peoples Security Bank and Trust for the fire protection tax that is collected. Darin DeRose seconded. Steve Roe said yes. Motion carried.

The Total Valuation for Real Estate and Certified Real Estate Value in Liberty Township is \$19,638,100.
